

Eligibility Criteria and Other Details for the Post of “Vice Chancellor”

Dr. D. Y. Patil Vidyapeeth, Pune was granted the status of (deemed-to-be) University under Section 3 of the University Grants Commission Act, 1956 on 11th January 2003. It comprises of a Medical College, a Dental College, a Nursing College, a Physiotherapy College, an Institute of Optometry and Visual Sciences, an Institute of Biotechnology and Bioinformatics, a Global Business School & Research Centre, an Institute of Distance Learning, a Homeopathy College and an Ayurved College. The Constituent Colleges/Institutes have excellent infrastructure with rich learning resource centers, state-of-the-art laboratories and dedicated faculty.

The Dr. D. Y. Patil Vidyapeeth, Pune is a **Category-I** Deemed to be University as per the provision of Categorization of the Deemed to be University under **UGC Regulations 2018** on [Categorization of Universities (only) for Grant of Graded Autonomy]. The Vidyapeeth has been re-accredited in March, 2015 by the National Assessment and Accreditation Council (NAAC) with a **CGPA of 3.62** in four point scale with **‘A’ grade**. The Vidyapeeth has also been ranked significantly at higher position under National Institutional Ranking Framework (**NIRF**), conducted by Ministry of Human Resource Development (**MHRD**), New Delhi. It has achieved **18th rank in Medical Category, 52nd rank in University Category and 79th rank in Overall Category** in India in **NIRF – 2018 ranking**.

The Vice Chancellor, being the academic as well as administrative head, is expected to be:

- A distinguished academician, with a minimum of ten years of experience as a Professor in a University system or ten years of experience in an equivalent position in a reputed research and/or academic administrative organization.
- He should have the highest level of competence, integrity, morals & institutional commitment.
- A visionary with proven leadership qualities, administrative capabilities as well as teaching and research credentials.

Service Conditions:

- The appointment will be for a period of five years or upto the age of 70 years, whichever is earlier.

Procedure for appointment:

- Appointment will be made from a panel of three names recommended by the Search-cum-Selection Committee.
